I. INTRODUCTION

This guideline supersedes Guideline No. 13 issued on February 6, 2014. The content has been updated to reflect changes to High School Equivalency Certificate requirements, as well as changes to the courses required to receive a high school diploma from the Division.

II. BACKGROUND

As of January 2014, the Division of Adult and Career Education no longer offers the GED ®. Instead, the Division offers a new High School Equivalency Exam recognized by the State of California. The California State Department of Education issues High School Equivalency Certificates to individuals. The Division recognizes all High School Equivalency Certificates issued by the State of California or any other state. The Division offers a high school diploma to students who earn a High School Equivalency Certificate and complete required coursework.

III. COURSE REQUIREMENTS FOR HIGH SCHOOL DIPLOMA

Students who pass the English High School Equivalency Exam will qualify for a high school diploma with the completion of 50 additional units of required coursework (as listed on the following pages). Students who pass the Spanish version of the High School Equivalency Exam are required to complete 70 additional units to qualify for the high school diploma.

IV. AWARDING CREDIT FOR SECONDAY COURSES

When evaluating transcripts, schools should refer to the current year's LAUSD Graduation Bulletin for the purpose of determining secondary courses that would satisfy graduation requirements.
